THIS BULLETIN IS BEING REISSUED TO SUPERSEDE PRODUCT CAMPAIGN BULLETIN 86C02 DATED FEBRUARY, 1986. UPON RECEIPT OF THE REISSUED BULLETIN 86C02(a), DESTROY 86C02.

General Motors has determined that some early 1986 Chevrolet Corvette models may experience a no-start condition or loss of fuel delivery on start up, and loss of anti-theft protection. This condition is the result of a malfunction in the vehicle anti-theft module.

To prevent this condition from occurring, a new module will be installed. In addition, new keys will likewise be furnished.

VEHICLES INVOLVED

Involved are certain early 1986 Chevrolet Corvette Models equipped with the "Vehicle Anti Theft System (VATS)" within the following parameters:

Involved vehicles have been identified by Vehicle Identification Number Computer Listings. OWNER NOTIFICATION

Owners will be notified of this campaign on their vehicles by Chevrolet Motor Division (see copy of Owner Letter included with this bulletin).

DEALER CAMPAIGN RESPONSIBILITY

Dealers are to service all vehicles subject to this campaign at no charge to owners, regardless of mileage, age of vehicle, or ownership, from this time forward.

Whenever a vehicle subject to this campaign is taken into your new or used vehicle inventory, or it is in your dealership for service in the future, you should take the steps necessary to be sure the campaign correction has been made before reselling or releasing the vehicle.

Owners of vehicles recently sold from your new vehicle inventory are to be contacted by the dealer, and arrangements made to make the required modification according to instructions contained in this bulletin.

PARTS INFORMATION

Parts required to complete this modification are to be obtained from General Motors Warehousing and Distribution Division (GMWDD). To ensure that these parts will be obtained as soon as possible they should be ordered from GMWDD on a C.I.O. order with no special instruction code, but on an advise code (2).

SERVICE PROCEDURE

THIS PROCEDURE INVOLVES WORKING NEAR THE ELECTRONIC CLUSTER. ADEQUATE PRECAUTION SHOULD BE TAKEN TO AVOID ANY ELECTROSTATIC DISCHARGE, (ESD) WHICH MAY DAMAGE THE CLUSTER.

- 1. REMOVE THE I/P CLUSTER TRIM PLATE
 - Pull off headlamp switch knob.
 - Move the steering wheel to it's lowest position and telescope it all the way out.
 - Remove the tilt lever from the column.
 - Unscrew the eight (8) screws holding the trim plate and remove it.
- 2. REMOVE THE I/P ACCESSORY TRIM PLATE
 - Four (4) screws hold it on.
- REMOVE THE I/P UPPER TRIM PAD. (Care must be taken when handling this pad to avoid damage to it.)
 - Remove three (3) screws above the cluster.
 - Remove the two (2) screws above the center display.
 - Remove the fuse box cover and the right hand I/P trim plate.
 - Remove the I/P pad screw located above the fuse box.
 - Remove the two (2) screws from the defroster duct.
 - Pull the I/P pad rearward and up to remove it.
 (If the car has speakers mounted on the pad the wires must be removed first.)

WHEN REASSEMBLING THE 1/P PAD BE SURE TO LINE UP ALL OF THE HOLES AND NUTS. FAILURE TO DO THIS COULD CAUSE A NOISE CONDITION TO EXIST.

DO NOT OVERTORQUE THE SCREWS AT THE DEFROSTER DUCT WHEN REINSTALLING.

SERVICE PROCEDURE (CONT'D)

- 4. REMOVE THE TOP TWO SCREWS FROM THE I/P CENTER TRIM PAD ASSEMBLY AND TILT IT FORWARD.
- REMOVE THE VATS MODULE. (2 SCREWS)
- INSTALL THE NEW VATS MODULE AND REVERSE THE ABOVE PROCEDURE TO REASSEMBLE THE VEHICLE.
- REMOVE LABEL FROM MODULE INDICATING KEY CODE.
 - 8. CUT THE THREE KEYS SUPPLIED TO MATCH THE IGNITION KEY ORIGINALLY SUPPLIED WITH THE VEHICLE.
- 9. RAISE HOOD. INSTALL CAMPAIGN COMPLETION LABEL. CLOSE HOOD.
- 10. START THE VEHICLE TO INSURE THAT THE SYSTEM IS WORKING PROPERLY.
- 11. DISCARD ORIGINAL IGNITION KEY(S) TO AVOID FUTURE MIX-UP.
